

Privacy Policy

Welcome to our website - UNIDOORS.GE. Please read our privacy policy carefully.

The privacy policy applies when you visit and/or interact with our website without purchasing any products, when you register at UNIDOORS.GE, and when you use our website.

The Privacy Policy makes you aware of how we collect, process and take measures to protect your personal data that can be used to identify you.

Any use of our website assumes that you have read, understood and accepted this privacy policy.

The website UNIDOORS.GE is managed by LLC "Unidoors". The limited liability company is registered in accordance with the legislation of Georgia. Our legal address is: Georgia, Kutaisi, Hualing Free Industrial Zone, Avtomshebeli str. #88, identification code 404636159.

1. Our Policy

UNIDOORS.GE respects your right to be informed about actions related to your personal data. When using data that directly or indirectly identifies your person, the principle of necessity applies. Therefore, the use of your personal data will be kept to a reasonable minimum and the use of such data shall not exceed the purposes for which it was collected and/or processed.

We will not process your personal data, while the service can be provided with anonymous data (such as marketing studies that improve our services) or other means that enable UNIDOORS.GE to identify you, except when it is strictly necessary or there is an administrative authority request (for example, in the case of data traffic and IP address).

2. Use of personal data and their purposes

Your data is collected and processed by UNIDOORS.GE strictly for purposes related to the use of the website and its services. However, your personal data may also be utilized in the performance of other operations within the scope of these specified purposes. Your personal data may be processed for the following purposes:

- a. When you register on our website, we collect your personal data (for example, your personal data, including your personal number, password, e-mail address) through the registration form (my page), in order to provide you with services in the secure areas of the website and to send you our information brochures, links in case of specific request;
- b. When requesting assistance, purchasing or returning products, we collect your personal data (for example, your first and last name, e-mail address and password) for the purposes strictly necessary to provide you with services related to UNIDOORS.GE and the purchase of products/on return;
- c. When requesting technical support, we collect your personal data to provide you with information related to browsing, web browser compatibility, and viewing and downloading UNIDOORS.GE web pages;
- d. For any other purposes permitted by the laws of Georgia. Your personal data is mainly processed by electronic means and in some cases physically (documents) to prevent fraud on UNIDOORS.GE. Your

personal data is stored in a way that allows UNIDOORS.GE to identify you for a certain period of time for the purposes for which the personal data was collected and processed as a result.

Your personal data will not be disclosed to third parties for purposes not permitted by the legislation in force in Georgia, or without your express consent. Your personal data will be shared with third parties only when necessary to process your request. Additionally, your data may be disclosed to administrative authorities only in cases established by law.

UNIDOORS.GE will process your personal data for direct marketing purposes, including via e-mail, only after receiving your consent. You can withdraw your consent to the processing of data for direct marketing purposes at any time and in writing, including by e-mail. In such a case, UNIDOORS.GE will stop processing your data for direct marketing purposes within a reasonably short period of time after receiving a written notification.

3. Non-disclosure of personal data to UNIDOORS.GE

The provision of your personal data (in particular, your personal details, e-mail address, residential address, telephone number) is necessary for you to provide UNIDOORS.GE with the services available on the website in accordance with your request. Your refusal to provide UNIDOORS.GE with personal data necessary for the above-mentioned purposes may result in us not being able to provide the services available on UNIDOORS.GE, such as sending informational messages. Therefore, failure to provide information may, in some cases, be a legitimate and justified reason for you not to use UNIDOORS.GE. Disclosure of other types of personal data to UNIDOORS.GE, which are not necessary for the fulfillment of obligations required by law or contract or for the provision of requested services, on the contrary, is voluntary and has no impact on the use of the website or its services or the provision of services to UNIDOORS.GE at reception. In some cases and if requested, from time to time, we will provide you with information that UNIDOORS.GE is required to disclose, either on a mandatory or voluntary basis, within a reasonable time. Be sure to indicate whether the information to be disclosed is mandatory or voluntary.

4. Data collection and security measures

When you use UNIDOORS.GE, some personal data may be processed automatically, for example, we automatically collect user IP addresses and other types of information related to user data traffic and user preferences when choosing services on this website. Information and data is collected automatically and directly by the website as part of its operational functions. This information and data is then processed collectively and anonymously for commercial purposes in order to improve the services available on UNIDOORS.GE. The website uses automatic data collection systems such as cookies. This is a device that is transferred to the Internet user's hard drive. It does not contain comprehensible information, but it allows the Internet user to communicate with his personal data, which are available to users on UNIDOORS.GE. Cookies are spread across our servers and the information stored in them is not accessible to anyone. Only UNIDOORS.GE processes the information collected by cookies and anonymously, in order to optimize its services and website according to the needs and preferences of users. We have linked cookies with functions such as the selected country, browsing the catalog, generally providing services intended for registered users. As you may know, each internet browser provides the option to delete

cookies after each session. Your Internet browser contains information about these deletion procedures. Please see the information in your internet browser if you want to delete cookies. Consent to the automatic data collection procedure and the use of cookies is necessary for the use of the website and its services. If you have started the process of deleting cookies, UNIDOORS.GE cannot guarantee that all UNIDOORS.GE websites will be displayed or the specified services will be provided.

5. Right of access to personal data and other rights

UNIDOORS.GE will process your personal data only after your consent, expressed freely, in order to send you advertising material and direct marketing or other types of commercial offers, including via e-mail, which do not fall under the user-requested services provided by UNIDOORS.GE. Each time your consent is required, we will inform you in advance and give you the choice to agree or refuse to use your personal data, including your email address, in accordance with the purposes specified above, by ticking accordingly. However, UNIDOORS.GE may process your personal data without your consent in certain cases that are not prohibited by law. In any case, we guarantee you to exercise the right and at your request, at any time and without giving any reason, not to receive future communications related to a particular service. You have the right, at any time, to receive confirmation that the data related to you is being processed or not, whether it is registered or not and in what process of processing, in an understandable form of communication. Moreover, you have the right to receive information about the source of your personal data, the purposes and methods of processing your personal data, the data controller, and to whom your personal data may be disclosed or made available.

At any time, you have the right to receive: 1. updated, corrected or when you have a similar interest, about your personal data; 2. deletion, transformation into anonymous form, blocking of your (illegally processed) personal data, including data that does not need to be stored for the purposes for which it was collected and further processed; 3. Consent to the operations mentioned above (with the same content) in which the data is disclosed or disseminated, except in cases where this is impossible or if the means used are clearly disproportionate to the protection of the right.

You have the right to object, in whole or in part, under the following circumstances: For legitimate purposes, you can object to the processing of your personal data, even if it is related to the purposes for which it was originally collected. You can object to the processing of your personal data for advertising or direct marketing purposes, as well as for conducting marketing research or commercial communications. You are free to exercise these rights at any time, provided that you do so in accordance with applicable law.

6. Regulatory legislation

Our company's data privacy policy is governed by the laws of Georgia, specifically the Law of Georgia on Personal Data Protection, which regulates the process of personal data processing. The Law on Personal Data Protection of Georgia ensures that personal data will be processed in accordance with the fundamental rights and freedoms of individuals, while also safeguarding their dignity, with special emphasis on confidentiality, identity, and the right to personal data protection.

7. Amendments and Modifications

UNIDOORS.GE reserves the right to change or update the Privacy Policy, either in whole or in part, in response to changes in regulatory legislation or data protection regulations affecting your rights. You will be promptly notified of any revisions or changes to the Privacy Policy, and these updates will become effective upon posting on this website.
